- 5. At approximately 10:50am (AEDT) on 6 January 2022 the Applicant's solicitors received an email from Mr Brown attaching the Decision. At approximately 11:14am (AEDT) the Applicant's solicitors replied by email, reiterating the Applicant's request for the Decision Documents to be produced urgently. I am informed by Penelope Ford of the Applicant's solicitors that, on the morning of 7 January 2022, she spoke with Mr Brown by telephone and, amongst other things, asked for an update on when we would be provided with the Decision Documents. Mr Brown indicated that his client was working on providing the Decision Documents to us, and that he would provide them as soon as they were available.
- 7. At approximately 3.17pm (AEDT) on 7 January 2022 the Applicant's solicitors sent an email to Mr Brown again requesting that he follow up on the production of the Decision Documents. The said email is annexed to this affidavit and marked 'NB-8'.
- 8. At approximately 5:33pm (AEDT) on 7 January 2022 the Applicant's solicitors received an email from Mr Brown that attached some of the Decision Documents and stated, amongst other things: "the delegate had the attached documents before him when making the decision under review". - 9. At approximately 5:37pm (AEDT) on 7 January 2022 the Applicant's solicitors sent an email to Mr Brown asking: "in the interview(s) which I have started listing to, certain copy documents were shown to our client by the interviewer. Can I assume that all of those documents are in this bundle?". At approximately 6.13pm, Mr Brown replied: "Yes, they are the documents that were copied by the delegate. The ATD and visa grant were viewed on line. I can let you have copies of same if you do not have them". At approximately 6.23pm, the Applicant's solicitors replied confirming that the Applicant wished to have copies of those documents.

Mr Novak Djokovic has been provided with a medical exemption from COVID vaccination on the grounds that this individual has recently recovered from COVID.

The date of the first positive COVID PCR test was recorded on the 16/12/21 and it has now been more than 14 days since the first positive PCR test. Mr Djokovic has not had a fever or respiratory symptoms of COVID-19, in the last 72 hours

This temporary exemption is valid until 16/5/22.

This certificate for exemption has been provided by an Independent Expert Medical Review panel commissioned by Tennis Australia. The decision of the panel has been reviewed and endorsed by an independent Medical Exemptions Review Panel of the Victorian State Government. The conditions of the exemption are consistent with the recommendations of the Australian Technical Advisory Group on Immunisation (ATAGI).
